HelloSign is used for executing documents with digital eSignatures. An eSignature (electronic signature) allows individuals to sign documents online, instead of using pen and paper. In other words, when a signer signs an online document willfully and intentionally, it's considered an eSignature. An eSignature works largely the same way as a handwritten or "wet" signature. - Not tech savvy? eSignatures are easier than signing the pin pad at the grocery store.
- Once a document is sent for signature, click on link located in your email and click sign.
- A signature can be executed by typing your name using keyboard, drawing a signature, or uploading a photo of your signature.
- This can be done on a computer, smartphone or tablet.
- Fast and Efficient!
  - eSignatures will improve efficiency in the signing document process by 90%.
    - (sign & auto-return PDF signed documents in less than a minute)
  - Removes the need for emailing/ mailing signed document after a document is signed!
    - After signing a document, both sender and signer receive an emailed "executed" PDF copy with a digital signature and receipt. Amazing!
    - Additionally, if you have a Dropbox account or Shareable Dropbox with SS+G, a copy is placed in the Dropbox automatically.

  - HelloSign authenticates document signers so you know who is signing your documents. Any person signing a document via HelloSign must either have login information or have received in their email account a signature request.
  - All user information transferred is 256-bit SSL encrypted, imposed automated session time-outs, and receive email every time a contract is sent to, received by, or signed under your account.
- 100% Legally Binding Signatures
  - HelloSign complies with the requirements of the U.S. Electronic Signature in Global and National Commerce Act of 2000 (ESIGN), the Uniform Electronic Transactions Act (UETA), and the European Union eIDAS (EU No.910/2014) regarding electronic signatures and transmissions legally binding.
